We are lucky that we live in Halton one of the most affluent communities in Canada. Even so, 8.5% of us live in poverty – meaning that a family of four lives on an annual income of less than \$41,000. And every year, 1,200 Halton residents become homeless due to the lack of affordable housing.

Fortunately, Halton is also a generous community – a community in which many have stepped forward to partner with Habitat for Humanity Halton. Some of our partners include:

- Genworth Financial, which pledged \$100,000 towards building a Habitat home in Oakville this year -- and \$10,000 for our ReNew It programme of interest-free loans to enable low-income families to undertake health and safety or accessibility improvements on their homes;
- The Town of Oakville, which supported out acquisition of two properties – and the Mayor and Council of Burlington's assistance in our biggest land acquisition ever;
- The Sprott Foundation, which pledged \$100,000 to help seed our aggressive growth plans over the next four years.;
- Halton Region's Housing Task Force, in which we collaborated, that identified immediate housing

development opportunities and solutions across the Region. Halton's grant support to Habitat is outlined elsewhere in this report by Regional Chair Gary Carr.

Habitat Halton's ReStore, at 1800 Appleby Line, is one of the most successful ReStores in Canada – again, thanks to our partners! Purchases at the ReStore finance 100% of our administrative costs and contribute much-needed financial support to our home ownership programmes. Many Halton retailers and home renovators donate much appreciated building materials to the ReStore. A few of our leading partners, deserving of support with your shopping needs, include:

- Home Depot's five Halton stores;
- Canadian Tire's Burlington and Oakville stores;
- Standard Paint & Wallpaper, Burlington;
- Interior Design House, Burlington.

Habitat's "Partner Families" are of course, our most important partner relationship. In addition to their interest-free mortgages, paid at rates affordable to them, each family contributes 500 hours of "sweat equity" to the many hours contributed by our valued community volunteers. We are proud to have partnered with the Salvation

Army, where our
Acton Family Partner
contributed much of their
"sweat equity", in order to
overcome a transportation
challenge – and with the Halton
Multicultural Council, with whom
new immigrant families are being
housed for their first three months of
settlement.

Finally, through Habitat Canada and Habitat International, we play a small role to help achieve our common vision in this increasingly global village, such as helping to re-build Haiti.

# A Message from... Regional Chair Gary Carr




On behalf of Regional Council, I'd like to thank Habitat for Humanity Halton, and the more than 750 corporate, faith community, and individual volunteers, who are finding real, meaningful ways to help families.

Your efforts to raise awareness about affordable housing in Halton ensure it is a message that is not forgotten.

Through the implementation of the Comprehensive Housing Strategy, adopted by Regional Council in 2006, Halton Region has committed to both preserving the affordable housing we have now, and to finding ways to help individuals and families in need.

On October 7, 2009 Halton Regional Council approved funding totalling \$3 million for eight new affordable housing initiatives in the Region. The process to allocate the funding to community agencies was spearheaded by Halton Region's Housing Task Force which was created in November 2008, to identify potential development opportunities for affordable housing in Halton.



Regional Council understands the vital role affordable housing plays in building a healthy and sustainable community. Whether it is a university graduate looking to settle down in the community where they grew up or a senior looking for accessible housing to help maintain their independence, the many reasons why Halton needs affordable housing touch each of us. Habitat for Humanity Halton has been one of our key partners, both on the Task Force and through the delivery of its initiatives: building new homes, ReNew It, and HomeWORKS.

I look forward to continuing to work together with Habitat for Humanity Halton so that we can build healthy communities for ourselves and our families throughout all phases of our lives.

"We were living in a basement apartment that was very cold and damp. We were always sick. The children couldn't go outside to play because the woman who lived upstairs didn't like them outside. She would always make lots of trouble for them.

One day I was watching TV and I saw a program on Habitat and how they had helped other families get a home. I thought, why shouldn't I try? What is the worst they could do? Say No! I wouldn't be any worse off and if they say yes my family will finally be safe and warm. We would have a home not just an apartment. So I applied. Thank goodness I did.

I went to the information session and decided that I was going to apply. It was not hard and Habitat was very helpful when I got stuck and needed help. When I found out I was approved I was at home with my boys and I started to cry. They thought I was sad but when I explained to them what was going on they were happy. I don't think they

really understood but my oldest son did. His name is Cody and he was 18. He told me he would help me any way he could.

When I started I knew nothing about building a house. I was looking forward to helping and maybe learning how tools really worked. The only tool I really knew how to use was a hammer and even that wasn't really good. Everybody was so nice and helpful and they helped me and now I have so many new skills. Cody was able to help with the building of the house too. He said it made him feel really good because he was able to help put a roof over his mother and brothers' heads.

I love coming home now. No more worries about the woman upstairs; will she be drunk or will she be yelling at us as we come in? Will the heat be



on? I now have
peace of mind and
body. The children love
playing outside. When we
go shopping and I have to
carry groceries in the house they
play outside. They have made new
friends with my neighbours' children
and they all play together. When they
go outside they run over and ask the
kids next door to come out and play.
We sit in the back yard in the summer
and have barbeques and the kids have
all kinds of pools and water slides.
They are very relaxed here. They now
know what it is like to have a home.

I was able to help put up the very first wall in the house. I was very excited. Laura and Emily are Habitat volunteers. They gave me a marker and told me to make my mark. I wrote a message for my boys on the wall. If they ever decide to remodel that wall and take it apart there is a message for them from me. I never would have thought to do that if it were not for Emily and Laura. Thank you."



#### 10th Anniversary - and 25th

- Supporting Habitat Halton's mission – as ReStore revenues finance 100% of Habitat Halton's administrative costs and contribute to our important programs.
- Our salvage crews helped grow revenues by 7%. The total number of kitchens and bathrooms salvaged and sold increased significantly. Salvage crew leaders Ray Smith, Dan de Verteuil, Mike Swartz, John Drake and Brian Duncombe coordinated this massive task.

### Habitat Halton Housing Highlights

- Habitat Halton's new home in Acton is the result of an innovative partnership with the Ontario Soybean Growers and Quality Engineered Homes. Introducing new "green" home building materials made from soy products, this Acton home is being purchased by a hardworking young family who have impressed everyone with the pace at which they have contributed their 500 hours of "sweat equity".
- Habitat Halton's partnership with the Halton Multicultural Council means that four newcomer families in need are each having the

opportunity to spend three months in a Habitat home. This is making a tremendous difference, enabling them to find employment and permanent housing solutions.

### Families and Businesses Help Build the Future

• Habitat Halton needs your help to acquire land and to create the revolving fund that enables us to build new homes. More individuals, families, and businesses are joining with us to make that possible. Leading by example, the members of our Board of Directors have personally committed over \$25,000 to date.

#### **Helping Out in Haiti**

# Our Campaign for Two Lots

#### Thank You, Oakville!

The purchase of two lots in Oakville this past year is a great example of Habitat volunteers, staff and board members working together to achieve a goal.

The volunteer Property Development Committee works to identify vacant parcels of land in Halton that would be suitable to our building program. In 2007 the Committee identified that the property at Elmwood and Margaret was owned by the Town of Oakville and could be declared as surplus. The property was situated in an established area and could accommodate, if severed, two houses.


Habitat kept this property in its focus and in June 2008 this property was declared "surplus" by the Town. Habitat immediately let the Town of Oakville know that it was interested in acquiring it, and the Campaign for Two Lots was underway.

As the first step of the Campaign, Habitat Halton requested that the Town of Oakville sever the property and make it available for sale. Board members, volunteers and staff requested letters of support for Habitat for Humanity Halton and the work that we do in the community from many organizations, companies, church groups and the Member of Provincial Parliament. Letters poured into the Mayor and Members of Council. With this support, Oakville Council approved an Official Plan Amendment to sever this property into two lots on May 29, 2009. The Campaign for Two Lots then

unleashed the power of Habitat volunteers. Volunteers wrote letters, e-mails and made phone calls to their Oakville Councillors and the Mayor. Volunteers and Board members met with Town Councillors. Organizations also helped reinforce this effort. The message was consistent; selling these properties to Habitat Halton was the right thing to do.

On July 7, 2009, a presentation was made to the Town of Oakville Administrative Services Committee by our (then) Executive Director Kathrin Delutis and Board member Terry Quinn, asking for their support to acquire this property at a price that was affordable to Habitat Halton, allowing us to give a hand-up to two families. Most Board members were in attendance to show support, and again reinforce the message that selling these properties to Habitat Halton was the right thing to do.

Terry Quinn, Habitat Halton Board Member and Stewart Hardacre, Habitat Canada's Chief Operating Officer were among those who led Habitat Halton's 'Campaign for Two Lots'



The following week, the recommendation from the Administrative Services Committee went before the full Town Council. No stone was left unturned. In preparation for the meeting, The Campaign for Two Lots ramped up. Meetings and requests for meetings with Councillors continued, along with letters, e-mails and phone calls.

On Monday, July 13th, Habitat Halton had several delegations speak at the Oakville Council meeting. Oakville Habitat volunteer Wendy Belcher, Habitat homeowner Darlene Howitt, and Habitat Board Member Susan Goetz first addressed Members of Council. Up next was Stewart Hardacre, President and COO of Habitat Canada, former Habitat Halton Board member and long-time Oakville resident. Habitat's presentation was then wrapped up by Ken Meinert, Oakville resident, former Habitat Canada Board Chair and leader of Habitat for Humanity's "Operation Home Delivery" in the aftermath of Hurricane Katrina.

Council had many questions. A vote was taken. Oakville Council voted to sell the properties to Habitat for Humanity Halton. As one Councillor said, "everywhere they turned during this process, there was another Habitat volunteer making their point".

Beginning this spring, two families will work with Habitat volunteers to build their new homes at the corner of Elmwood and Margaret. The Campaign for Two Lots was successful, thanks to the power of Habitat volunteers.

New & Used Home Renovation Supplies

From affordable purchases – to donations of building materials for a tax receipt:

## The ReStore

is a Win-Win Proposition

One family's salvaged kitchen is another family's proud renovations. A Burlington family sent the photos below of their newly renovated house to the ReStore. Their email informed us: "Here are some pictures of what we call the 'Habitat Home'. We have purchased so much from your store that it has made the renovations so much more affordable. Thank you."

When people renovating their kitchen or bathroom call us, we send a salvage representative to assess the items with the family and arrange a date when we can remove them at no cost. The items are brought to the ReStore and sold, along with any appliances being replaced. The donor receives a tax receipt for the value at which salvaged units are sold. It's a positive outcome all around and, rather than ending up as landfill, the items are re-used -- and appreciated.

Many ReStore products are donated by stores, corporate offices, manufacturing companies and wholesalers. In addition to the affordable prices paid by the happy new owners, the landfill diversion credits paid by Halton Region also help to support Habitat Halton's community programs.

Maureen Champagne, ReStore Manager, felt the economy slowing in 2009: "No one was buying and they weren't donating either." Fortunately in August people started buying, renovating and donating again. By January the ReStore outperformed any year in its seven-year history.

The ReStore has now launched a computer recycling program. People bring in their computers, their laptops, or printers and they are recycled for free.

Tracey Pingle, who works at the ReStore, is a strong advocate of the GreenTech program. Tracey points out that: "The policy is zero export and zero landfill, so the program aims to reuse all the parts and all the toxic materials are taken care of. It's difficult to dispose of computers responsibly in Burlington. But people don't want their old computers to become land-fill, so this is a program that fills an important community need."

And the ReStore now operates "green" as well. We had Burlington Hydro install all new lights, reducing the amount of electricity used, with better quality, brighter lights that should last a lifetime.







## Thank You to All of Our

Habitat for Humanity has reached a leadership position in building affordable homes around the world and in the Halton Community. Through the support of volunteers, partners and donors, Habitat for Humanity Halton has broken the cycle of poverty for 11 families in our community. As the families pay their mortgage these funds are pooled, and in turn used to build more affordable homes. The ReStore has increased its revenues every year as our customer and donor base has grown. Now one of the top Habitat ReStores in Canada, we are justifiably proud of the quality of its products and the compliments we receive from our customers. The revenue generated from ReStore sales covers all of Habitat Halton's administration costs, meaning all donations go towards



# Halton cultural Council

For many years Halton Region has been considered a world class place to live. Life seems almost perfect here.

We have great schools, easy access to wonderful amenities, green parks, golf courses, gourmet restaurants, fashion stores and some of the most prestigious neighborhoods. To most, it seems that life could be perfect for anybody here. Far from this reality are the stories of many local people and newcomers who struggle trying to afford everyday living. Affordable housing is one of the biggest challenges in our region and, sadly, many of those who are born here are forced to move away because of affordability issues. However, agencies such as Habitat Halton and the Halton Multicultural Council have been able to give a twist of hope to this reality and to help families remain where they belong.

In 2009, Habitat Halton and the Halton Multicultural Council entered into a partnership agreement offering temporary accommodation for a family in need at a Habitat home in Acton. The purpose of the partnership was to offer the house as an emergency shelter for

newly arrived families who wanted to make Halton their home.

Halton Multicultural Council discovered a Milton family with two young children and a baby girl who were at imminent risk of eviction. This family from Mexico arrived in Canada in 2008; they did their best to grow as a family and individuals, but circumstances were not on their side.

After labour cuts affected the breadwinner, and the mother's sickness after a baby's delivery, the situation turned from bad to worse. Despite this, the two older children were maintaining remarkable grades at school and gaining their teacher's admiration for their behaviour and successful adaptation to Canada. The landlord was about to evict this family when Halton Multicultural Council offered them a lifeline.

It meant leaving Milton and moving to Acton, helped by their former neighbours who always believed they were great people. While Habitat Halton recruits a partner family to purchase the home, this families is able to resolve their special settlement challenged. They moved into the three-bedroom house where the kids are exchanging their struggle for tranquil family days in a Habitat house they now call home.

# Building a House from



Tess and Emil Nicolas

In late June of last year, Liza Carr read a column in the Acton newspaper and saved it for her friends, Emil and Tess Nicolas and their ten-year-old daughter, Margot. Emil wanted to own a home with a yard and the freedom for Margot to play with her friends on their property. Yet, Emil and Tess could not afford a house at Halton prices.

This is why the newspaper column caught their imagination. Habitat Halton was going to erect a two-bedroom prefabricated 'soy house' in Acton and was seeking a partner family for the home. Tess and Emil went to an information session and learned about Habitat, the long-term, no-interest

mortgage on Habitat homes and the 500 hours of volunteer work called 'Sweat Equity'. Then Emil took a chance, "I thought we might qualify, so we applied. And not long after that we got a phone call from Habitat Halton telling us that they would pay us a visit."

"At this point we were already excited at the thought that our application might be approved. And soon after that we actually got approved. So you can imagine how excited and happy we were. We were very lucky, because I didn't think that we were going to own a house that soon," Emil said.

The Nicolas family weren't the only ones enveloped in a whirlwind of excitement.

David Cole, Construction Manager at Habitat Halton also had his hands full, "There are a lot of little things that come together when building a house - but this time it was on steroids because we had to do everything on such short notice." Habitat Halton heard about the prefabricated house a few days after acquiring property on Peel Street in Acton. Quality Engineered Homes was building a 'Soy House' in their factory, working with the Grain Farmers of

This house highlights how environmentally sustainable soy bean oil can be used in house construction. Soy is used in the No-VOC paints and varnishes, bathroom fixtures, adhesives and insulation in place of petroleum oils. After "The Royal" the house needed a permanent foundation and Habitat Halton placed a bid. This was the beginning of a unique partnership.

Ontario, for the Royal Winter Fair in

Toronto.

The timing of the Royal Winter Fair gave Dave a tight schedule, "We purchased the land, got all the clearances and permits and put the foundation in all in record time. It typically takes about three months to get approval in this process, but we managed to do it in seven weeks. The second we had a building contract, there was a crew waiting to put a hole in the ground!"

Dave says "the proof of the pudding" was when Habitat Halton blocked off Peel Street in November and Quality Engineered Homes wheeled in two semitrailer trucks - each carrying half a house - and craned each piece into place for a



House Landing Ceremony. "When they touched the house down and it actually fit the foundation that we'd built, I think we all breathed a sigh of relief."

Emil, Tess, and Margot were at Peel Street for the landing, "We were excited, happy and nervous at the same time. Some of our friends were there also to witness the house landing. It went well. The house is just lovely. Perfect for us three."

Emil, Tess, Margot and their friends have also been working away at their 500 hours of Sweat Equity. "It feels good working on a house that soon will be yours," Emil said. "When we move into the new house, it will be very different for all of us. Our daughter is only 10-years-old and she still enjoys playing. Her friends used to invite her to play in their backyard. Now I'm sure she will be happy to know that she too can also invite her friends to come over to play in our backyard. And the mortgage will be less than what we are paying in renting the apartment \*. So it will be more affordable for us." The Nicolas family is due to move into their new home this Spring.
